¹ Cotton ratio is higher than 100% because part of what is exported in one year comes from accumulated stocks from previous seasons.² There is no reliable data on farm based quantity exported in 2003.³ The average is based on each commodity's share of production value. To account for dairy products, the 2002 ratio (5%) was used.
